



Nintendo Press Portal – Terms of Use

Terms

The use of the Nintendo Press Portal ("Press Portal") is only permitted on the basis of the following Terms of Use. The Terms of Use include all other rules for the use of the Press Portal on the Press Portal. You can find the current version of these Terms of Use at <https://www.nintendo-europe-press.com>. Please read these Terms of Use carefully. They contain important information on the scope and limits of the rights of use to the media content of this Press Portal (see Section II). I. Registration in the Press Portal Access

Access to the Press Portal is only available to persons who register for the Press Portal.

Registration, access and use are reserved only for certain groups of people of legal age, in particular journalists, Nintendo employees, agencies and content creators for specific purposes, for the exercise of professional, commercial or self-employed professional activity and not for private purposes. Please make sure that your access data (username/password) are not accessible to third parties. We reserve the right to take action against unauthorised use of the Press Portal and/or to block the corresponding account. This applies in particular to people who have provided false information during registration, provide data of other people or use the account(s) of other people. When you register for the Press Portal, we collect certain personal information from you. For more information on how we use and process this data, please refer to the privacy policy. When you register for the Press Portal, you will receive a confidential password from Nintendo for the first login. Once you have successfully logged in for the first time, you have to replace this password with a password of your choice. You can then log in with the e-mail address you provided during the registration and password of your choice. You must keep the access data confidential. In particular, you are obliged not to provide the access data to third parties or to make them accessible. If you suspect that a third party has learned your password, you are obliged to change it immediately. You can use the function provided for this purpose within the Press Portal or request a new password via help@pressxtra.net

II. Intellectual Property Rights, Copyright Notices

1. Ownership of Rights

All rights to all content on the Press Portal, including articles, press releases, artwork, screenshots, graphics, logos, digital downloads and other files, are owned by Nintendo, unless they belong to third parties who have licensed them to Nintendo. The content is protected by national and international copyright laws and treaties or by other intellectual property laws. Trademarks, work titles, and copyrights for game titles and characters from other publishers are owned by the companies that market or license these products.

2. License Terms for Press Portal Content

The following license terms apply to all content (including articles, press releases, artwork, screenshots, graphics, logos, digital downloads and other files) that are expressly made available through this Press Portal (hereinafter: "Portal Content"):

Subject to these License Terms, Nintendo grants you, free of charge, the non-exclusive right to use the Portal Content (except for download codes; see below for license terms regarding download codes), solely for the purpose of inclusion in editorial content, such as news articles, reviews, videos, interviews, news reports, etc., which may then be distributed, broadcast or made publicly available in broadcast, print and/or electronic media.

It is not permitted to use the Portal Content in connection with the creation of dedicated video game strategy guides and/or walkthroughs.

It is not permitted to replicate the Portal Content in a simple gallery format, i.e. uploading the Portal Content and making it available without any added editorial content or commentary. You may use the Portal Content for the above-mentioned purposes, but not for other purposes - e.g. commercial or advertising.

Regarding digital content download codes that are distributed through the Press Portal, Nintendo grants you, free of charge, a non-exclusive, non-transferable, non-sublicensable and limited right to use the download code including the contained digital content only for the following purposes:

- review or preview of the product,
- the preparation of a review and/or other commentary or literary or audio-visual content about the products.

The publication of the review/article about the product in publications must be done in adherence with these Terms of Use.

Download codes must only be redeemed by the authorised user of the Press Portal account that receives the code, and may not be forwarded, sold on, made available online or otherwise distributed to third-parties in any way.

The terms of pre-release download code distribution are governed by the Framework Embargo Agreement and the individual Schedule to Nintendo Framework Embargo Agreement.

3. Except for the above-mentioned purposes, the Portal Contents may not be used and, in particular, may not be reproduced, distributed, publicly reproduced or otherwise exploited. Any transfer or sublicensing of the rights of use granted to you, even in part or temporarily, is not permitted. For the avoidance of doubt, it is stated that you are prohibited in particular from reselling digital downloads or download codes made available to you in this Press Portal or otherwise transferring them to third parties or making them accessible for a fee.

You are not entitled to modify Portal Content, except in the case of pure text from articles or press releases. In the latter case, they are not allowed to modify the texts in such a way as to change their meaning or context. Of course, your right to write your own texts about Nintendo products, as long as they are not based on the modification of a Nintendo press release, remains completely unaffected. To the extent that the Portal Content (a) contains trademarks or trade names of a third-party company or (b) is similar to or related to a third-party company, you are responsible for obtaining any necessary permissions and licenses.

4. Other content All content other than the Portal Content described above may only be used to the extent necessary for the display of the respective website on the user's screen. In particular, it is prohibited to reproduce, download, transmit, forward, modify the design or layout of the Press Portal or the materials and information published on it - not even in parts or in other file formats - or to record them on paper, CD-ROM or other electronic data carriers or storage devices (e.g. in databases or on other websites). Further, this other content may not be used: (i) on other websites, in other publications or public performances; (ii) in connection with any non-Nintendo products or services; (iii) in a manner that is likely to create a likelihood of confusion by customers; (iv) in a manner that would disparage or discredit Nintendo; (v) for exploitation for commercial purposes; or (vi) if such use would otherwise infringe Nintendo's intellectual property rights or copyrights.

III. Restriction and Termination of the Account

1. You can terminate this user agreement at any time by deleting your user account.
2. Nintendo is entitled to terminate the User Agreement in whole or in part with a notice period of two weeks.
3. Furthermore, Nintendo may terminate the User Agreement without notice for good cause. In particular, there is an important reason:

- a. in the event of prolonged inactivity or change of employer or activity deposited;
- b. in the event of serious violations of the Terms of Use, in particular a violation of clauses 2, 3 and/or 4 of Section II, as well as the transfer of your usage data to third parties, constitutes a serious violation;
- c. when using the Press Portal for a purpose other than the intended purpose;
- d. in the event we suspend or withdraw the Press Portal. The Press Portal is made available free of charge. We do not guarantee that the Press Portal, or any content on it, will always be available or be uninterrupted. We may suspend or withdraw or restrict availability of all or any part of the Press Portal for business or operational reasons.

IV. Limitation of Liability and Warranty

1. Nintendo shall only be liable for intent and gross negligence. The same applies to Nintendo's representatives, employees and vicarious agents.
2. The above exclusions and limitations of liability do not apply to liability for claims based on statutory product liability law or for bodily injury (life, limb, health).

V. Changes to the Terms of Use

Nintendo reserves the right to amend these Terms of Use, provided that the contractual relationship is not adversely affected by you. Changes to the Terms of Use are also possible, provided that they do not change the main performance obligations of the contractual relationship between Nintendo and you. Nintendo will notify you in advance of any changes to the Terms of Use. If you do not object within six weeks of notification of the changes, the amended Terms of Use shall be deemed to have been accepted and shall enter into force against you on the date specified by Nintendo, but not earlier than the expiry of the objection period. In the notification of the change to the Terms of Use, Nintendo will specifically draw your attention to your right to object and the consequences of the expiry of the objection period.
